As a requirement for consideration as an applicant into the Veterinary Technology program of Hinds Community College, all applicants are required to obtain no less than 35 hours of observational experience prior to your interview. These hours must be completed in a veterinary clinic. We do not accept hours from animal shelters.

You will notice there are two sections to this form; **Section A** is to record observation hours and **Section B** is show employment if you are currently employed in a clinic. If you are currently employed in a clinic we will gladly accept that as your observation requirement. **The deadline to submit this form is May 22, 2024.**

- If you have the opportunity to obtain observation hours in different clinics – Do it!
- If you have the opportunity to obtain both large and small animal observation- Do it!

- What is your typical day; work hours and expectations of a veterinary technician
- What do they feel like are the rewards of being a CVT?

- What are the job opportunities for a CVT such a specialization in a specific field such as dentistry, anesthesiology, radiology, emergency care.
